

Report of the Chairman of the Building of the Century Campaign

THE MODERN WING opened in May 2009 to critical acclaim and enormous popular success. Following a more than five-year fund-raising campaign, the Modern Wing opened fully funded and endowed, with more than \$400 million having been raised for the design, construction, and endowment of this historic building addition and related capital projects. The Building of the Century Campaign ranks as the most successful fund-raising effort ever undertaken by a Chicago cultural institution.
